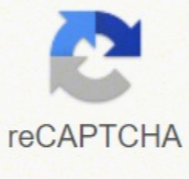

## CHAPTER 3

## Investigation Request and Preliminary Investigation

This chapter follows the suggested agency forensic investigation protocol and staffing discussed in Appendix A. It covers preparing and evaluating investigation requests, deciding to proceed or not to proceed with an investigation based on the request, initiating a forensic investigation, undertaking a background study, identifying issues of interest and preparing objectives to address them, collecting relevant information, determining whether a forensic evaluation is justified, preparing a preliminary investigation report, and recording the decision to proceed or not to proceed with a forensic investigation.

## 3.1 Preparing a Forensic Investigation Request

A forensic investigation begins with a formal request (example Form #1 in Appendix C) from an agency employee or from an organization undertaking research or other work on behalf of the agency (e.g., a university research center or an appointed consultant) to the forensic investigation coordinator (discussed in Appendix A). The requestor:

1. Completes the formal request that includes contact details, location of the issues to be investigated, the reasons for the investigation (why the investigation needs to be carried out and how the results will be used), a summary of work already undertaken that prompted the request for the investigation, details about the project that the issue is part of, and a justification for urgency. Preliminary details about the project may include, but are not limited to:
  - Pavement structure and surface type.
  - Date opened to traffic.
  - Suspected source of problem.
  - Length of the project or proportion of job affected.

2. Submits the request to the agency forensic investigation coordinator.

## 3.2 Evaluating a Forensic Investigation Request

On receipt of the request, the forensic investigation coordinator:

1. Acknowledges receipt of the request form.
2. Opens a project file and starts a budgeting/cost-tracking spreadsheet and/or assigns a charge number for team members to book time to during the investigation.
3. Issues an investigation number. This number should include the year plus a consecutive number as a minimum (e.g., 2011/01), but can include other agency specific data that will facilitate later retrieval (e.g., district, route number and post-mile, pavement type, investigation type code, etc.).
4. Evaluates the request and determines whether the request should be supported. This may require discussion with the requestor to fully understand the request intent and issues to be investigated. Reasons to consider a request inappropriate include:
  - The problem is identical to one that has already been investigated or is currently being investigated.
  - The problem is clearly linked to a known construction deficiency (e.g., compaction requirements were not met and were not corrected at time of construction).
  - The issues can be clearly linked to normal pavement behavior/deterioration.
  - The issues can be linked directly to a known event (e.g., severe rutting linked to the issuance of an abnormal load permit).
5. Records whether the investigation should be supported or not on the request form and signs the form.

**Abstract**  
Law practitioners are an underestimated but well-versed in the application of digital forensic technologies, and require the development of a proper methodology to systematically search digital devices for significant evidence. Computer fraud and digital crimes are growing day by day and unfortunately less than two percent of the reported cases result in conviction. This paper explores the development of the digital forensic process model, compares digital forensic methodologies, and finally proposes a systematic model of the digital forensic process. This model attempts to address some of the shortcomings of previous methodologies, and provides the following advantages: a structured, standardized and systematic framework for digital forensic investigation process, a framework which systematically in turn according the captured evidence is structured, to apply the framework to uncover the security digital forensic investigation technologies, a generalized methodology that judicial members can use to relate technology to non-technical elements.

This paper present a brief overview of previous forensic models and propose a new model named from the DFFWD Digital Investigation Model, and finally compares it with other previous model to show relevance of this model. The proposed model in this paper explores the different processes involved in the investigation of digital forensic process model. The systematic digital forensic investigation model (SDIFIM) has been developed with the aim of helping forensic practitioners and organizations for setting up appropriate policies and procedures in a systematic manner.

**1. INTRODUCTION**  
Computer forensic emerged in response to the escalation of crimes committed by the use of computer systems either as an object of crime, an instrument used to commit a crime or a repository of electronic evidence in crime. Computer crimes have first been noted in 1946 when the FBI Laboratory and other law enforcement agencies began developing programs to examine computer evidence. Research groups like the Computer Analysis and Response Team (CART), the Scientific Working Group on Digital Evidence (SWGDE), the Technical Working Group on Digital Evidence (TWGDE), and the National Institute of Justice (NIJ) have since been formed in order to discuss the computer forensic science as a discipline including the need for a standardized approach to examinations [1].

**Abstract** - Computer Forensics is essential for the successful prosecution of computer criminals. For a forensic investigation to be performed successfully there are a number of important steps that have to be considered and taken. The aim of this paper is to define a clear, step-by-step framework for the collection of evidence suitable for presentation in a court of law. Existing forensic models will be surveyed and then adapted to create a specific application framework for single computer, entry point forensics.

## 1. Introduction

Over the past few years, computer forensics has risen to the fore as an increasingly important method of identifying and prosecuting computer criminals. Prior to the development of sound computer forensics procedures and techniques, many cases of computer crime were left unsolved. There are many reasons why an investigation might not lead to a successful prosecution, but the predominant one is a lack of preparation. The organization investigating the suspicious behaviour often lacks the tools and skills required to successfully gather evidence. Individuals attempting to investigate such suspicious activity may also lack the financial resources financial resources or tools to conduct such an investigation adequately and ensure that the evidence is undisputable in all circumstances. Moreover, there are instances when all of the above have been adequately put in place by an organization, but, due to a lack of training and correct procedure, the evidence collected can easily be disputed.

As a result, computer forensics seeks to introduce cohesion and consistency to the wide field of extracting and examining evidence obtained from a computer at a crime scene. In particular, the extraction of evidence from a computer is performed in such a way that the original incriminating evidence is not compromised. This is also useful when presenting a case without the support of legal expertise, as is often the situation since many organizations and individuals do not have in-house or personal legal representation.

This paper will propose a three phase framework that can be followed systematically to produce forensically sound evidence. The framework is an adaptation or combination of several existing forensic models.

The paper is structured as follows: the subsequent section will clarify important terminology used in the field of forensics; the third section will briefly discuss some

#### Haze: A Danger to Health

The haze is a constant phenomenon faced by Malaysia and her neighbouring countries. The haze is basically pollution of atmosphere, which is clogged with pollutants and other substances from forest fires.

The haze is a direct effect of forest fire in Kalimantan and other parts of Indonesia due to slash and burn method of farming. The culprits must be brought to justice, either through healthy fine or prison sentence. Constant vigilance would ensure the perpetrators do not repeat their offence.

The government should also raise the public awareness of the dangers of forest fire.
